

Pacific Power Design Professional Honorarium Washington and California

Purpose of the honorarium

To encourage design professionals involved in new construction and major renovation projects to participate in Pacific Power's Energy FinAnswer or FinAnswer Express incentive programs early in the design phase when the opportunity to influence the project is higher.

How much is the honorarium?

The honorarium is \$1,000*, and one honorarium can be paid per project.

Requirements for an honorarium payment

- **Timing** – Honorarium application and Pacific Power Letter of Intent signed by the customer must be provided to Pacific Power prior to completion of schematic design documents. Pacific Power must not already have a signed Letter of Intent for the project.
- **Project type** – Project must be new construction or major renovation
- **Customer** – Customer must be served on a Pacific Power general service rate schedule and located in California or Washington

Eligible Schedules:

California - A-25, A-32, A-33, A-36, AT-47, AT-48, AWH-31, LS-53, LS-58, OL-42

Washington - 24, 36, 40, 48T, 54
- **Professional design services procured** – Customer/owner must have a contract for design services such as the traditional AIA documents or any agreement where the professional is paid for design services whether or not the owner constructs the project.
- **Applicant** – Person requesting the honorarium must be a registered design professional on the design team

How to submit a lead and request an honorarium payment

Send the following to Pacific Power:

- A Letter of Intent signed by the customer/owner
- A completed Design Professional Honorarium application

In some cases, to determine eligibility, a copy of the design services agreement between the design professional and the customer may be required.
