Re: Revision to LED/SSL Policy – *FinAnswer* Express Program

The policy applicable to general illuminance LED/SSL incentive eligibility has been revised and is effective for all projects with a valid Incentive Agreement or eligible post-purchase application. This policy supersedes all previous *FinAnswer* Express LED/SSL qualification policies.

To qualify for incentives, any general illuminance LED product submitted for an incentive must be listed on at least one of the Qualified Fixture List options below. Documentation of LED listing must be included for each product type submitted and must be included with the submitted project documentation.

Option 1: ENERGY STAR qualified fixtures and lamps list:

- The majority of products on Energy Star list are lamps or recessed can fixtures.

Option 2: DesignLights Consortium's Commercial Fixtures qualified list:

- The majority of products on this list are fixtures (interior or exterior)

Option 3: Lighting Design Lab's LED Qualified Fixture and Tubular LED lamps list:

- This list uses the same ENERGY STAR qualification standards to obtain product certification, but is designed for a faster review and approval process (3 to 4 weeks). If your product is not on one of the first two lists above (option 1 or 2), check the LDL list.

The above lists are generally updated with a minimum of 1 month intervals and have been centrally located for quick access by the Lighting Design Lab at the link above. For information on the lists or how to get a product qualified, please refer to the websites above.

If the product is NOT listed on one of the above three lists, contact the manufacturer to obtain these certifications or consider using a listed product. Option 4 can be used as an alternate means of product qualification until December 31, 2011. **Effective January 1, 2012, general illuminance LED products will be required to be on one of the above three lists to be eligible for incentives.**

Option 4: PacifiCorp *FinAnswer* Express LED Qualified Product list:

- PacifiCorp maintains a pre-existing list of LED products that were qualified based on the requirements of the prior LED policy. If the LED product is on PacifiCorp's list, it is eligible for incentives. If the LED product is not on PacifiCorp's list, submit an application and all the documentation requirements for Option 3 (above) to the Lighting Design Lab's qualification process. PacifiCorp will no longer accept checklists from the prior LED policy after October 1, 2011.

Non-general illuminance LEDs and other notes:

- Please note that non-general illuminance lighting (i.e. LED Message Center, Channel Letter, and Refrigeration Case lighting) requires NRTL certification, but does not require pre-qualification through one of the options listed above.
- Low-voltage LEDs are exempt from meeting the NRTL certification but must be listed on one of the qualified listed websites above.
