**JOINT CROSS STATEMENT AND
EXPEDITED MOTION TO MODIFY
THE PROCEDURAL SCHEDULE**

Under OAR §§ 860-001-0390(2)(b), -0420(1), and -0420(6), Public Utility Commission of Oregon Staff (Staff), PacifiCorp, the Oregon Department of Energy (ODOE), Renewable Energy Coalition (REC), Industrial Customers of Northwest Utilities (ICNU), and the Community Renewable Energy Association (CREA) (collectively, the Movants) file this joint cross statement and motion to modify the procedural schedule.

I. Joint Cross Statement

The Movants are the only parties who have filed testimony in this docket. The Movants do not intend to cross-examine any witnesses. Each of the Movants reserves the right to conduct follow-up questioning or examination of any witnesses who are cross-examined by other parties or questioned by the Administrative Law Judge (ALJ) or Commissioners.¹

¹ The following parties have intervened, but have not filed testimony, in this docket: Renewable Northwest, Northwest Independent Power Producers Coalition, Cypress Creek Renewables, and Portland General Electric Company.

II. Expedited Motion to Modify the Procedural Schedule

Under the current procedural schedule, prehearing briefs are due on September 5, 2017.

In light of the Movants' waiver of cross examination, the Movants respectfully request an expedited order modifying the procedural schedule as follows:
