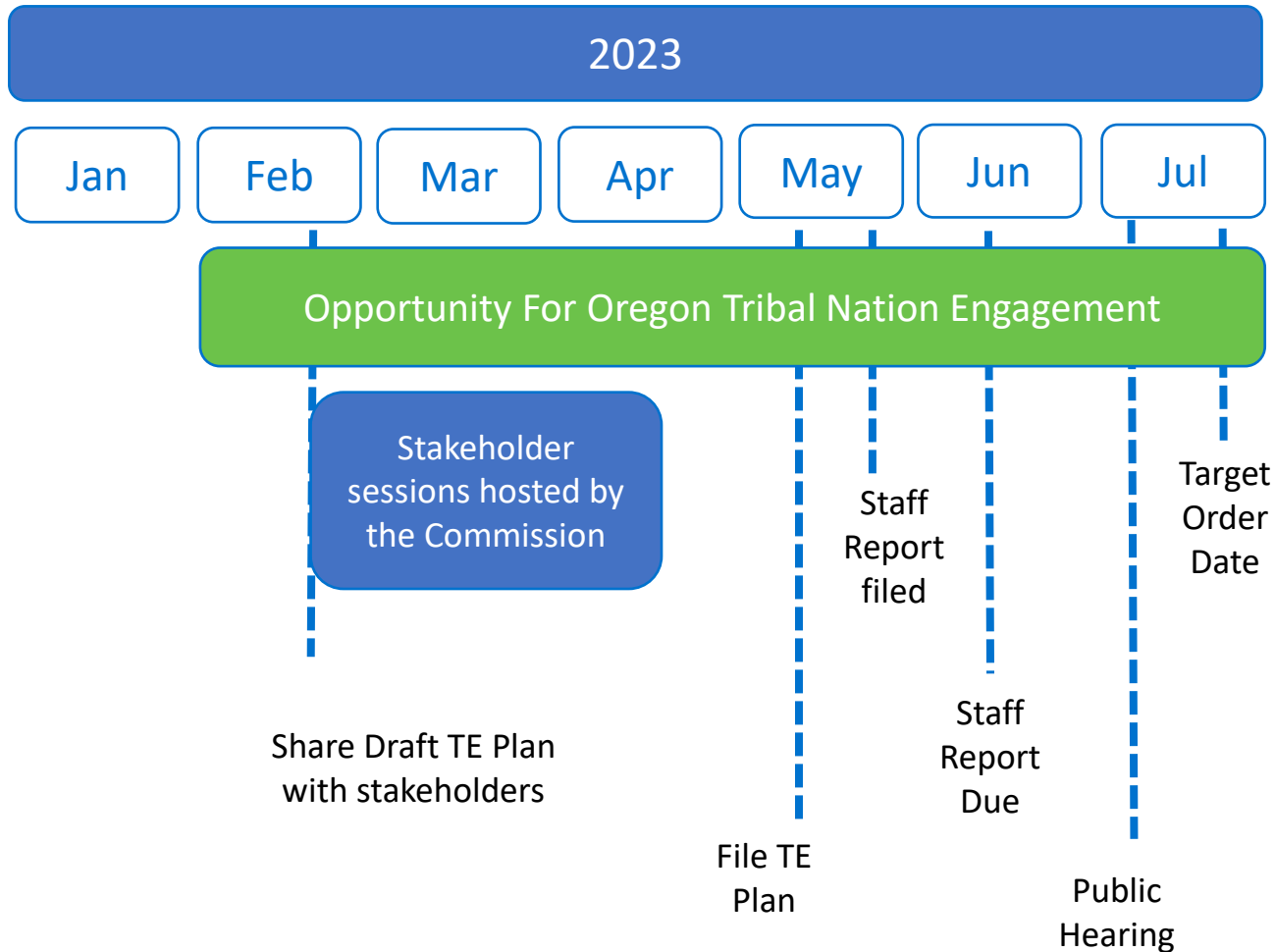

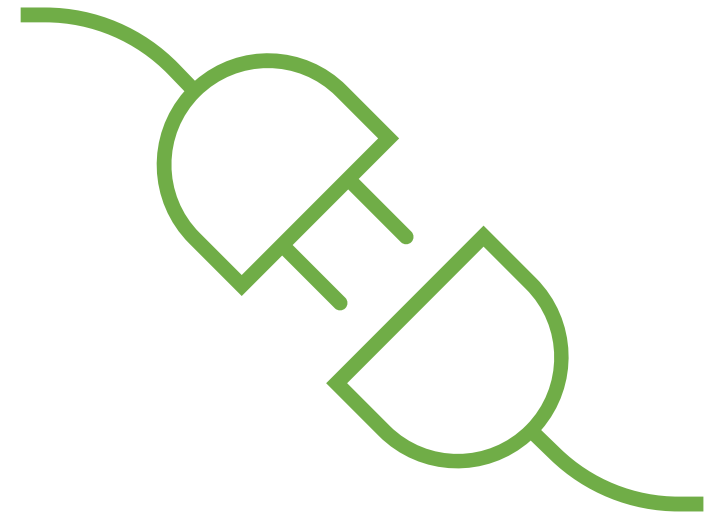

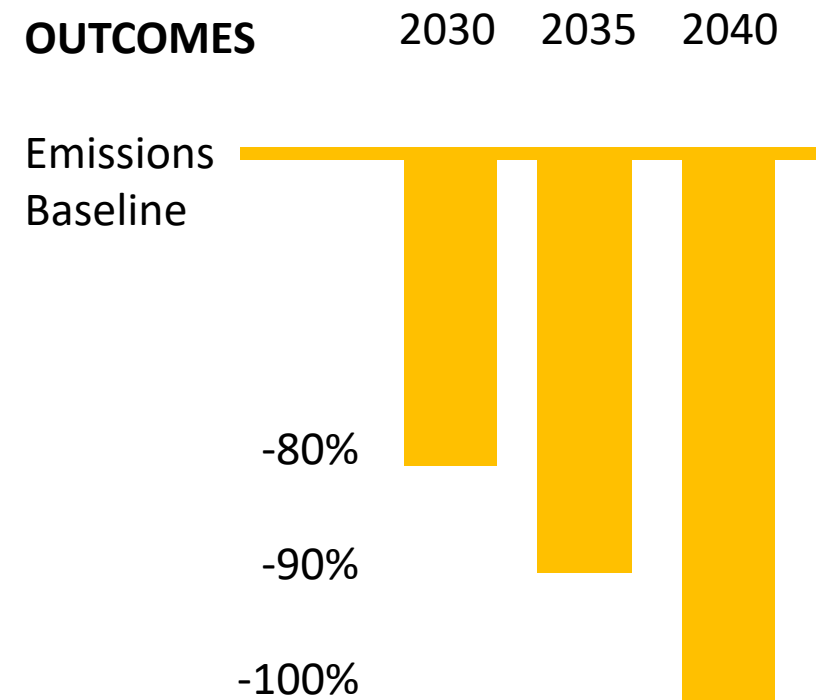
Transportation Electrification grants and programs can increasingly support the unique needs of Tribal Nations in Oregon.

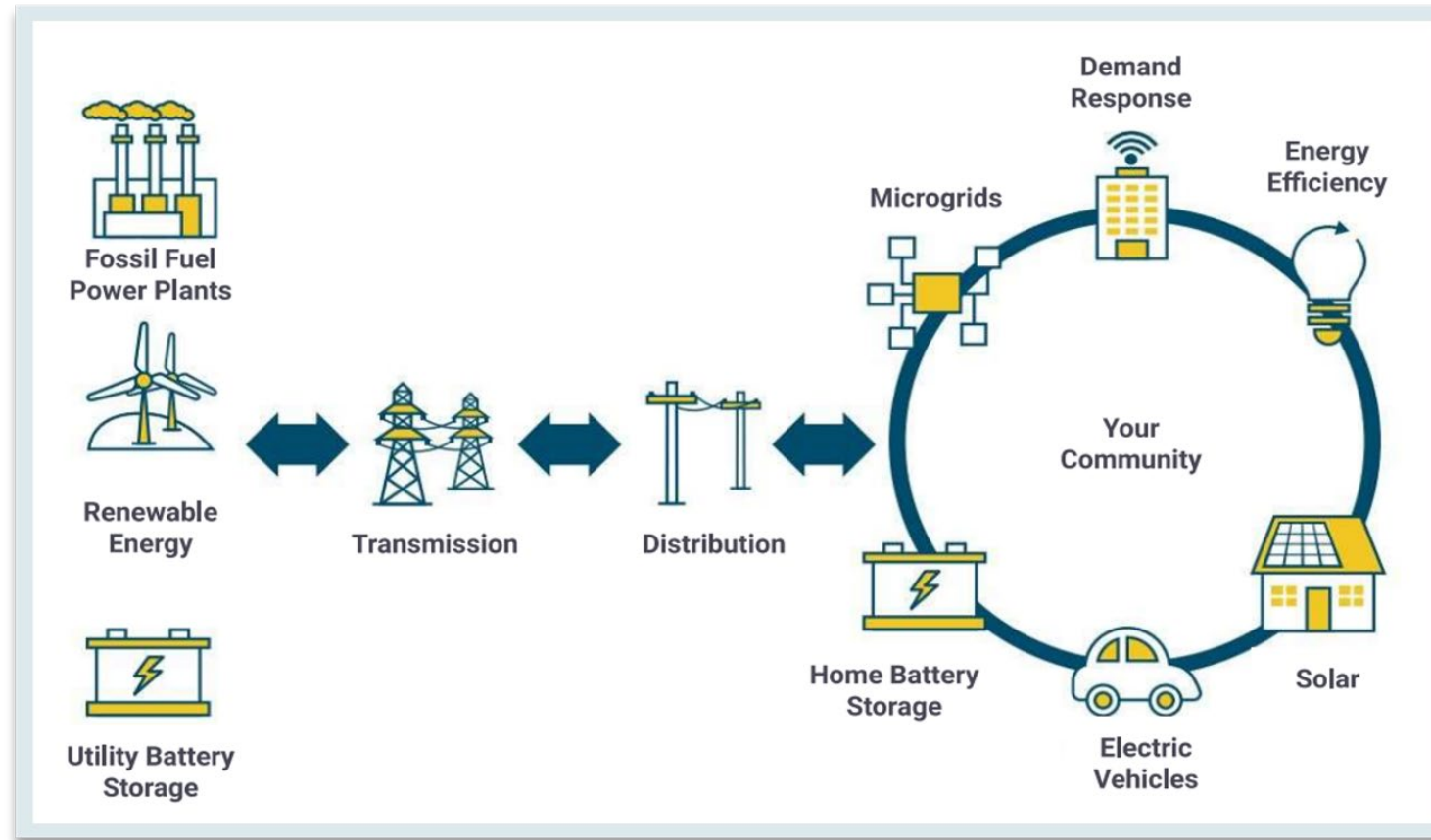
Oregon's Clean Energy Future

In 2021, Oregon Governor Brown signed House Bill (HB) 2021 into law, which provides an emissions-based clean energy framework for electricity providers to develop Clean Energy Plans (CEP). The plan requires retail electricity providers to reduce greenhouse gas emissions associated with electricity sold to Oregon consumers.



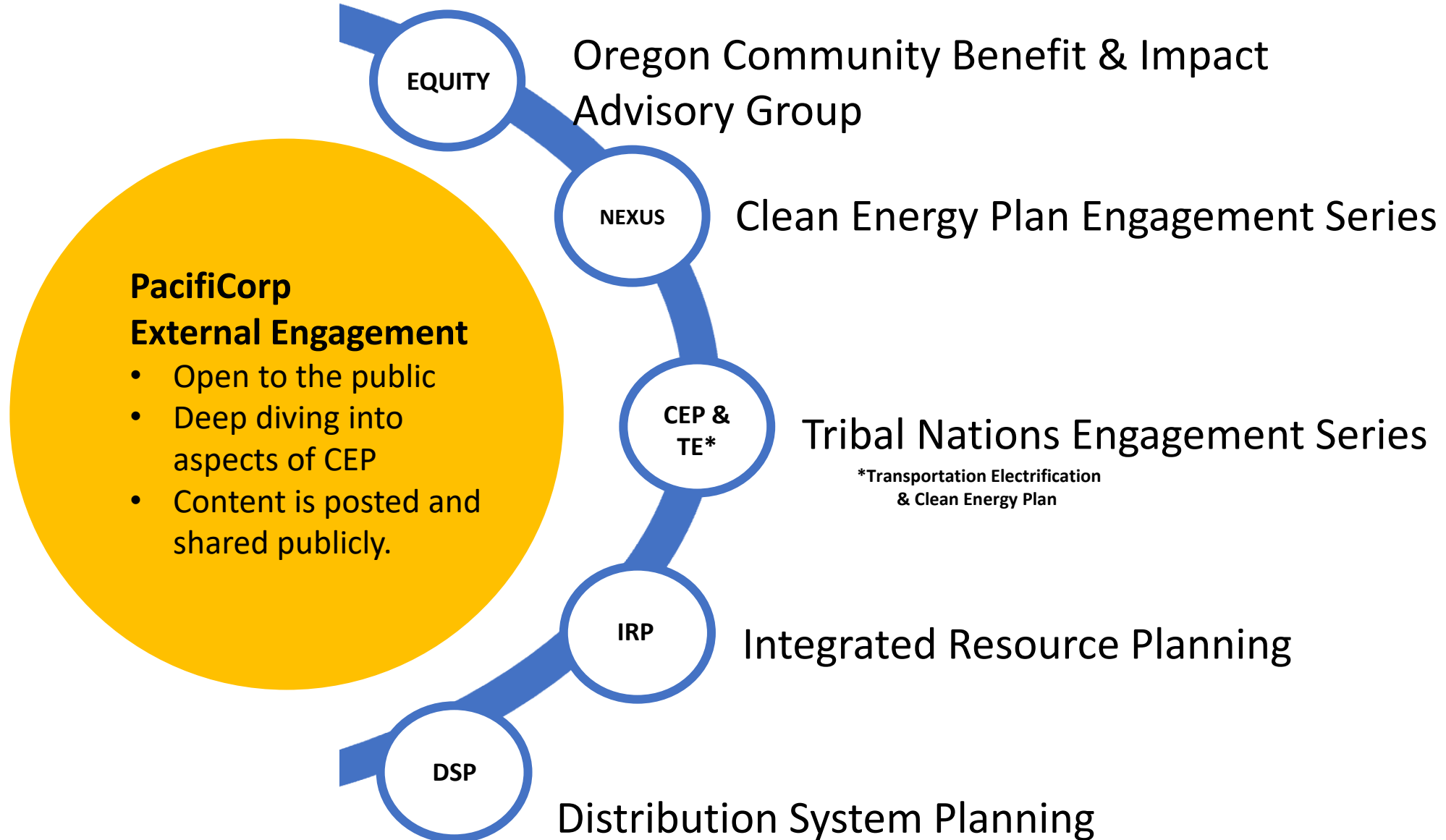
PacifiCorp will file first Oregon Clean Energy Plan in 2023.

Pacific Power and Energy Trust of Oregon are holding “Be Wattsmart” workshops in Oregon communities this year.

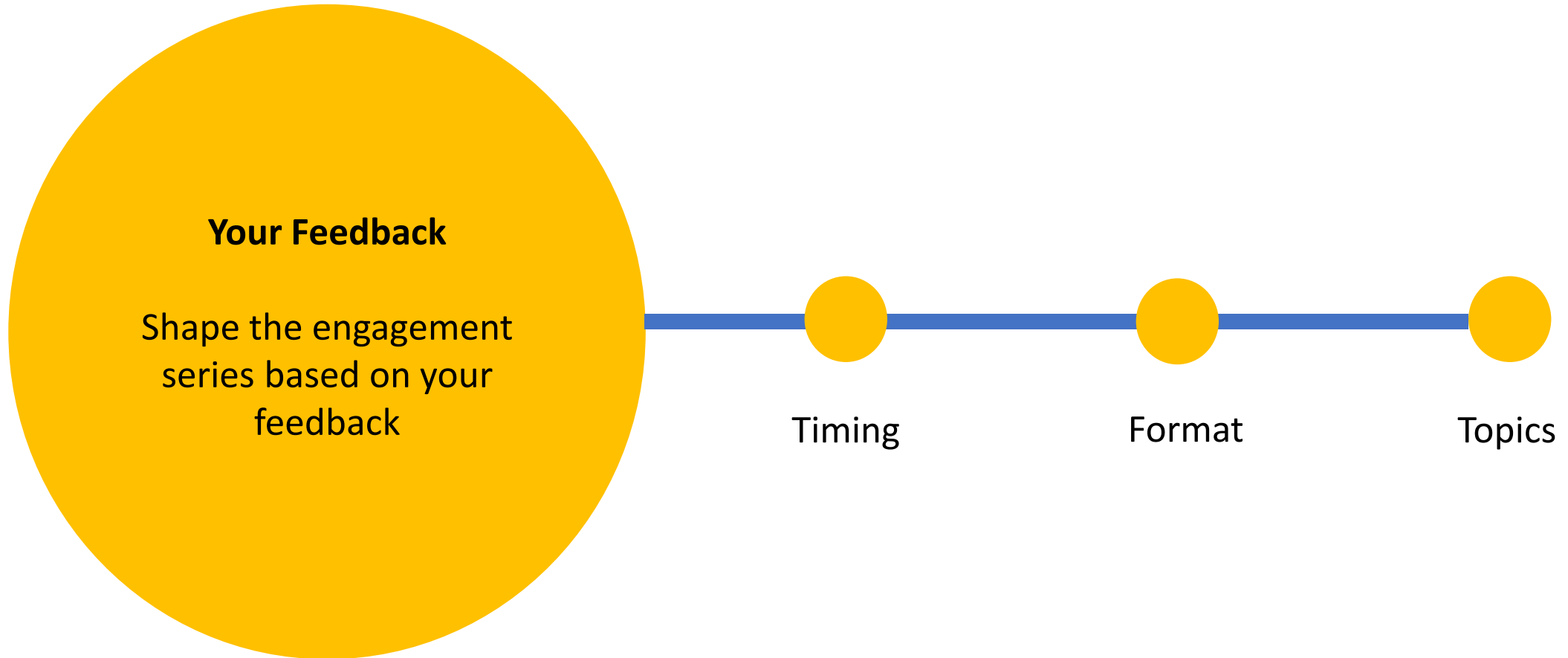

- Free program, includes dinner, hosted at local, community venues



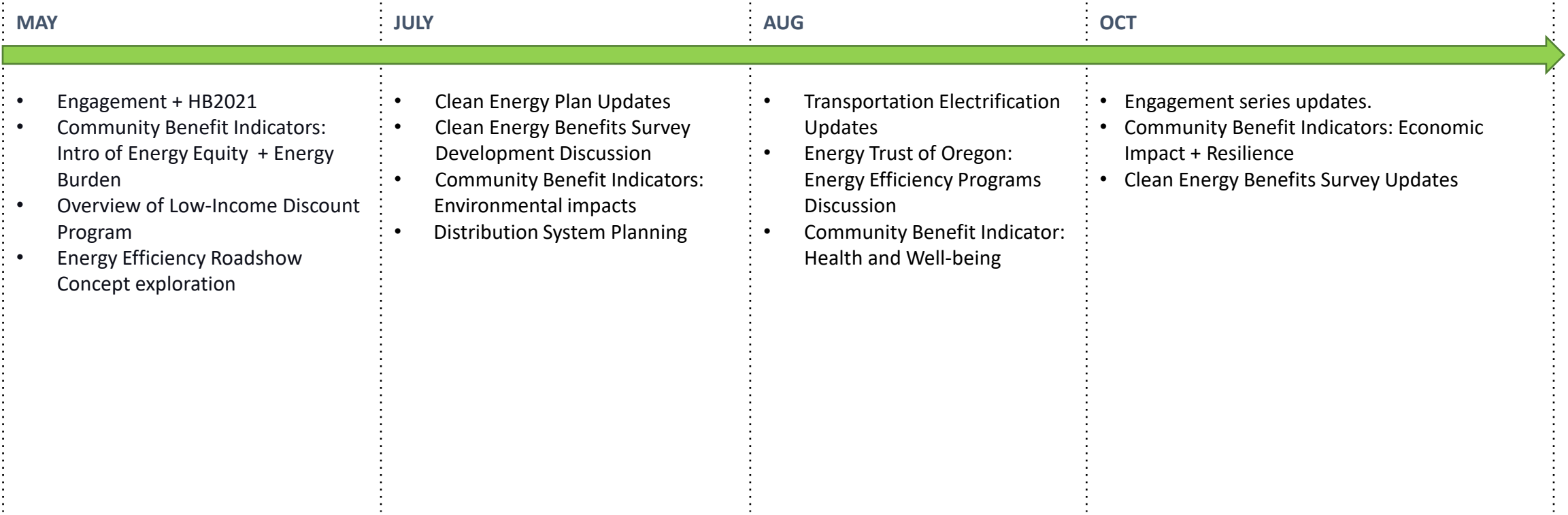
Topics covered:
