

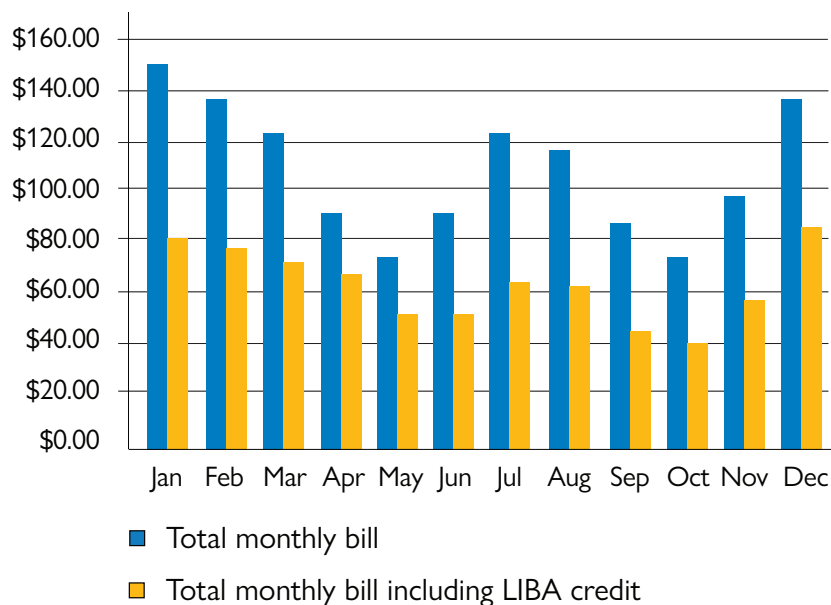
Pacific Power's Low Income Bill Assistance Program (LIBA)



Reduce your Pacific Power bills year-round. The Low Income Bill Assistance Program (LIBA) is available to income-eligible households, and there are many benefits to participating:

- You could save approximately \$650 each year. LIBA credits are dependent on monthly electricity usage.
- The energy assistance program, LIHEAP, averaged about \$500 per household last year. By taking advantage of both LIHEAP assistance and LIBA credits, you could save more than \$1,100 a year.
- Enrolling in LIBA is easy and the requirements are similar to the LIHEAP program.
- Discount varies between 15%, 35% or 70% of net bill based on income qualification level.

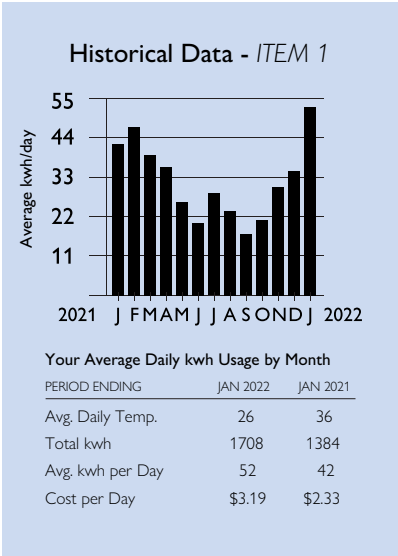
If you participate in the LIBA program, you may see significant reductions in your Pacific Power bill. The chart below shows average monthly LIBA savings.



The LIBA discount is applied toward the total bill excluding taxes.

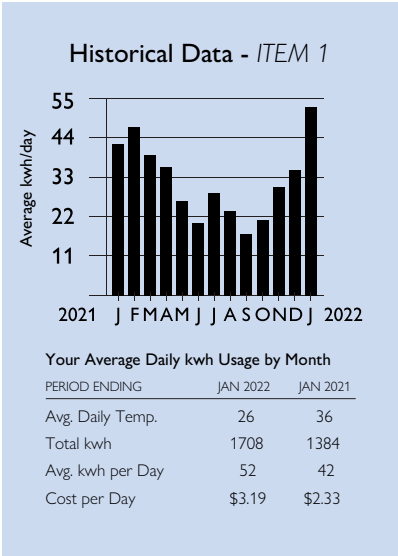
