

SCHEDULE EVSUB

SERVICE FOR SUBMETERED PLUG-IN ELECTRIC VEHICLES

APPLICABILITY

This Schedule is applicable to Customers served under a Residential or Non-Residential rate schedule where a plug-in electric vehicle (PEV) is charged at the premises through the same meter that registers the Customer's principal load and where the connected PEV load is measured by an approved Customer owned or an approved third-party owned PEV submeter (submeter load) and where the Customer chooses to separate the PEV load from the principal load at the premises for separate billing under the Company's tariffs.

TERRITORY

Within the entire territory served in California by the Utility.

MONTHLY BILLING

The Monthly Billing shall be calculated separately for the Customer's principal load and the PEV submeter load where each is billed under the applicable rate schedule. The Customer's principal load is the load from the Company-owned meter less the PEV load.

SPECIAL CONDITIONS

1. **Customer Enrollment in Submetering Services:** The Submeter Meter Data Management Agent (Submeter MDMA) is the third-party responsible for enrolling the Customer under this schedule and providing monthly submeter data to the Company for Monthly Billing. The Customer is responsible for acquiring a Company approved Submeter MDMA and requesting the Submeter MDMA submit for enrollment. The Company will maintain a list of approved Submeter MDMA's. Upon receiving a completed Customer Enrollment Agreement from a Company approved Submeter MDMA, the Company will begin service for the Customer under this rate schedule within 30 days. Once enrolled, the Customer will see the Monthly Billing on this rate schedule starting with their next billing cycle.

2. **MDMA Services for the PEV Submeter:** Customers, or their Submeter MDMA's, are required to provide, own, operate, and maintain the submeter used for this Schedule. The standards for qualified submeters are contained in the Plug-in Electric Vehicle Submetering Protocol (EVSMP) which was provided as Attachment A to the California Public Utilities Commission's Order Instituting Rulemaking to Continue the Development of Rates and Infrastructure for Vehicle Electrification in Rulemaking 18-12-006.

Submeter MDMA's are required to perform certain meter data management services (Submeter MDMA services) related to providing secure, properly formatted, accurate, and timely data submission to the Company. These requirements are listed in the EVSMP.

SPECIAL CONDITIONS (continued)

3. **Principal Load and Submeter Load:** All Customers served under this Schedule will be billed for usage for their principal load and PEV submeter load on their electric bills as if each load was a separately metered point of delivery. The Customer's principal load will be calculated as the load measured by the Company's meter less the load measured by the PEV submeter which has been submitted to the Company from the Submeter MDMA. The principal load and the PEV submeter load will be separately billed under the rate schedule applicable to each load in accordance with the Monthly Billing section of this schedule.

4. **Billing Adjustments:** The Company will not be obligated to make a billing adjustment pursuant the Company's Rule 9 on either the principal or submeter account due to revisions or adjustments provided by the Submeter MDMA after the Customer's electric bill is issued for that month.

The Company is not responsible for inaccurate or incomplete data provided by the Submeter MDMA or for failure of the Submeter MDMA to comply with data formatting, data submission or data security requirements of this schedule. If the Company and the Submeter MDMA are unable to resolve submeter billing or data issues, the Company will not delay the monthly billing for the Customer and will bill the Customer at the primary meter rate under the applicable schedule for the time intervals during which the disputed charging occurred.

5. **Disenrollment:** The Submeter MDMA or Customer must report all program participant drop-outs or change of address to the Company within ten business days of the decision to disenroll from this Schedule. As of the effective date of the drop-out or change of address, the Company will default to using the applicable rate schedule of the principal meter for all load at that premises. The Company will effectuate any required rate and billing changes coincident with the start of the Customer's next billing cycle. If the Submeter MDMA has terminated the submetering service to a Customer or the Customer has relocated to a new service address, the Customer may re-enroll by having a Submeter MDMA submit a new Customer enrollment form.

7. **Submeter:** The submeter must be located at a fixed point anywhere between the principal meter and the PEV. All submeters must meet UL safety requirements or be embedded within a device that meets UL safety requirements, or comply with the Company's specific safety requirements and must meet standards specified in the EVSMP.

SPECIAL CONDITIONS (continued)

8. **Submeter Meter Data Management Agent (Submeter MDMA):** The Submeter MDMA is the entity that retrieves, processes, and submits PEV submeter data using validation, editing, and estimating methods, as outlined in EVSMP, and provides this information to the Company for billing purposes. Whether the Submeter MDMA, the Customer, or other third-party owns the submeter, the Submeter MDMA is responsible for obtaining authorization from the Customer to access and submit this information on the Customer's behalf. The Submeter MDMA must submit a completed Customer Enrollment Agreement to the Company. The Submeter MDMA cannot be the customer of record. The Company will maintain a list of approved Submeter MDMA's. The Company reserves the right to reject future applications from a Submeter MDMA which has previously failed to comply with the data security requirements of this Schedule.

9. **Data Security:** The Submeter MDMA and all vendors must, at a minimum, ensure confidentiality agreements and data security measures comply with the requirements described in the EVSMP and the Company's Rule 27 to safeguard customer usage and personal information. Submeter MDMA's which fail to comply with data security standards may be rejected by the Company which may result in the disenrollment of the Customer from this program. The Company will notify the Customer if their Submeter MDMA is rejected based on data security requirements.

CONTINUING SERVICE

Except as specifically provided otherwise, the rates of this tariff are based on continuing service at each service location. Disconnect and reconnect transactions shall not operate to relieve a Customer from minimum monthly charges.

RULES AND REGULATIONS

Service under this schedule is subject to the General Rules and Regulations contained in the tariff of which this schedule is a part and to those prescribed by regulatory authorities.
