## PRELIMINARY STATEMENT PART A

#### 1. TERRITORY SERVED

The territory served by this Utility in California includes Siskiyou County, Modoc County, Del Norte County, Trinity County and Shasta County.

#### 2. DESCRIPTION OF SERVICE

Service is intended to be continuously available. Service is alternating current, 60 hertz, single-phase or three-phase, at one of the nominal standard voltages given in Rule No 2.1.

#### 3. PROCEDURE TO OBTAIN SERVICE

Any person can obtain electric service from Pacific Power & Light Company by making application in accordance with Rule No. 3 and if required by signing a contract in accordance with Rule No. 4. Each applicant will be required to satisfactorily establish credit. Where an extension of the Utility's lines is necessary or a substantial investment is required to supply service, applicant will be informed as to the conditions under which service will be supplied. Applicants for service must conform to and comply with the Utility's tariff schedules.

#### 4. ESTABLISHMENT OF CREDIT AND DEPOSITS

A. Establishment of Credit:

As set forth in Rule No. 6, credit may be established as follows: (1) cash deposit, (2) previous regular payment of bills, or (3) otherwise to the satisfaction of the Utility.

B. Deposit:

Where credit is not otherwise established, deposit will be required in an amount as set forth in Rule No. 7.

### 5. GENERAL

A. Measurement of Electric Energy:

All electric energy supplied by this Utility to its customers shall be measured by means of suitable electric meters, except energy delivered under outdoor area lighting and street lighting tariff sheets on a rate-per-lamp basis, and energy estimated from load and operating time data, for highway sign lighting, traffic control and other installations where metering is impractical.

> All rates hereinafter listed are net rates and are not subject to discount, except those rates where a discount is specifically stated.

Standard Riders: D.

No standard riders are used by this Utility.

Ε. Lamp Service:

> This Utility does not furnish any lamps, either original installations or renewals, except for Outdoor Area Lighting Service and Street Lighting Service.

F. Magnetic Field (EMF) Measurements:

> The Company shall provide on site magnetic (EMF) field spot measurements once during any consecutive six month period, at the request of Customers or property owners. Measurements provided by the Company will be at no charge. Measurements shall be made at or near the Company's facilities, and be of a type, number, and at locations determined by the Company. Measurements do not include diagnostic investigation of electric systems beyond the Company's point of delivery. The Company shall provide to the Customer or property owner a written summary of the measurements that it takes. The Company may refer the Customer or property owner to other agencies, when in the Company's determination, their request for EMF measurements is not covered by this rule. The Customer or property owner shall be responsible for payment of any charges for EMF measurements which they request from other agencies.
