

**STREET LIGHTING SERVICE CONSUMER-OWNED SYSTEM  
 DELIVERY SERVICE**
**Available**

In all territory served by the Company in the State of Oregon.

**Applicable**

To lighting service provided to municipalities or agencies of municipal, county, state or federal governments for dusk to dawn illumination of public streets, highways and thoroughfares by means of Consumer owned street lighting systems controlled by a photoelectric control or time switch.

**Monthly Billing**
**Energy Only Service - Rate per Luminaire**

Energy Only Service includes energy supplied from Company's overhead or underground circuits and does not include any maintenance to Consumer's facilities. Maintenance service will be provided only as indicated in the Maintenance Service section below.

The Monthly Billing shall be the rate per luminaire specified in the rate tables below plus the applicable rate in Schedule 80 and applicable adjustments as specified in Schedule 90.

**STREET LIGHTING SERVICE CONSUMER-OWNED SYSTEM  
DELIVERY SERVICE****Supply Service Options**

All Consumers taking Delivery Service under this schedule shall pay the applicable rates in Schedule 200, Base Supply Service. Additionally, each Consumer shall specify Supply Service Schedule 201 or Schedule 220, as appropriate and in accordance with the Applicable section of the specified rate schedule. If Consumer elects to receive Supply Service from an ESS, Delivery Service shall be provided under Schedule 753, Direct Access Delivery Service.

**Franchise Fees**

Franchise fees related to Schedule 200, Base Supply Service, Transmission & Ancillary Services, Schedule 201, Net Power Costs, and distribution charges are collected through rates in this schedule.

**Provisions**

1. The Company will not maintain new Consumer owned street lights. Such maintenance will be the responsibility of the Consumer, however the Company may install pole identification tags for the purpose for tracking unmetered Consumer owned lights.
2. Consumer owned lights, mounted to Company owned distribution poles, shall be installed, maintained, transferred or removed only by qualified personnel.
3. The entire system, including the design of facilities, installation of fixtures on Consumer poles, and wiring suitable for connection to Company's system, will be furnished by the Consumer. Electrical connections to Company facilities shall be performed by Company personnel or Company contractors.
4. Consumer must notify the Company in writing of any changes to the street lighting system which would affect billing, including new installations, removals or wattage changes. Standard notification procedure will be through online forms at [www.pacificpower.net/streetlights](http://www.pacificpower.net/streetlights).
5. All new underground-fed lights on this schedule will require a Consumer installed means of disconnect acceptable to both the Company and the local electrical inspecting authority.
6. Temporary disconnection and subsequent reconnection of electrical service requested by the Consumer shall be at the Consumer's expense.
7. Where approved by the Company, all pole mounted outlets used for holiday or other decorations, as well as traffic or other signal systems, will be supplied with service on a metered General Service rate schedule via a Consumer-installed meter base.

**Term of Contract**

Not less than one (1) year for both new and replacement fixtures.

**Rules and Regulations**

Service under this Schedule is subject to the General Rules and Regulations contained in the tariff of which this Schedule is a part and to those prescribed by regulatory authorities.
