California Meter Aggregation Requirements

Pursuant to California Public Utility Code Section 2827 and Pacific Power Schedule NEM-35, the customer electing to participate in net metering aggregation, by completing this form, agree to the following terms and conditions:

- 1) The energy generated by the Customer's eligible Renewable Electrical Generating Facility and exported to the Pacific Power grid shall be allocated to each meter listed on this form in proportion to the electrical load served by those meters,
- 2) The Customer warrants that all of the aggregated meters listed below:
 - a. Serve the Customer's load and must be under the same account number; and,
 - b. Are located on the same property as the Renewable Generating Facility; or,
 - c. Are located on property that is adjacent or contiguous to the property on which the Renewable Electrical Generating Facility is located and those properties are all solely owned, leased or rented by the Customer.
- 3) Meters participating in net metering aggregation shall permanently be ineligible to participate in Net Surplus Compensation (NSC), and Pacific Power shall retain any kWH in excess of the eligible Customer Generator's electrical load as determined for each aggregated meter individually.
- 4) The Customer agrees to remit charges for billing services as required under Schedule NEM-35. Currently these fees equal \$25.00 per meter for set up charged on the first bill and a recurring \$5.00 per meter fee per month on each account included in the aggregation arrangement.

This agreement at all times shall be subject to such modifications as the California Public Utilities Commission may direct from time to time in the exercise of its jurisdiction.

For aggregation arrangements requesting and additional service for the generator- Subject to all other applicable rules, an additional service may be allowed for the Generating Meter if it has no load other than that associated directly with the Renewable Electric Generation Facility. However, a customer may not subsequently add load to that additional service.
