## Changes to Wattsmart Business Lighting Instant Incentive Offer in Washington

Effective September 4, 2022, Pacific Power is changing the incentives for several lamp categories in the Washington Wattsmart Business Lighting Instant Incentive offer. The table below is marked to show the changes relative to the current program.

Qualifying lamps purchased starting on September 4, 2022, may be eligible for the new (revised) incentives.

Qualifying lamps purchased prior to September 4, 2022, may be eligible for the prior incentives.

## Background:

It is Pacific Power's intent to adjust the incentives periodically to address market conditions for lighting (changes in material costs, product availability, and price competition), and align with Pacific Power's defined savings target, incentive budget and cost-effectiveness requirements. When a change is needed, Pacific Power will post a notice on its website announcing the coming changes. The notice will be posted at least 45 days prior to the changes taking effect.

Pacific Power aims for Instant Incentives to align with incremental cost assumptions from the Regional Technical Forum (RTF) when possible. The lighting market, however, is currently experiencing lamp pricing increases that are not accounted for in the RTF assumed incremental costs for midstream lamps. Therefore, Pacific Power is increasing some lamp incentives to better align with the current market conditions for lighting and increase program participation. The T8 TLED lamp category will also be expanded to include separate incentives for the different types of T8 TLED lamps so incentive levels can be better aligned with expected costs and savings.
