INSTANT INCENTIVES FOR LIGHTING:

Pacific Power's Wattsmart Business is offering instant incentives for qualified LED lighting when purchased from a participating instant incentive distributor. The incentives are intended to help customers with routine maintenance and small improvements. If you're already working with a lighting vendor on a lighting project, please note that only one incentive is available per lamp.
