HVAC EQUIPMENT

According to ENERGY STAR[®], heating and cooling accounts for 40-50% of energy used in businesses. In addition, you're likely to experience improved comfort and productivity as well as reduced HVAC repair costs. If your current HVAC unit is more than seven years old, it may be time for a replacement. See if a Ductless Heat Pump or one of the other measures below can help reduce your energy usage.

OTHER MEASURES

- **Evaporator Fan Motors** Electronically commutated (EC) motors reduce energy use and improve cooler/freezer performance.
- Anti-Sweat Heater Controls Humidity-sensing controls ensure heaters run only when necessary, reducing energy use and costs.
- Heat Pump Water Heaters Heat pump water heaters use less energy than a conventional water heater which can lower your energy bills and save you money over time.
- Engine Block Heater Controls Heater controls that ensure the heater runs when needed reducing energy use and costs.

STEPS TO PARTICIPATE

- Step 1: Contact an approved Wattsmart Business Vendor Network contractor. To find an Approved Vendor, call us toll free at 1-855-805-7231 or use the Find a Vendor tool.
- Step 2: Review vendor recommendations and choose whether you want to move forward with any or all of the recommendations. Then submit a completed Wattsmart Business General Application, include form W-9.
- Step 3: Approved Vendor installs your selected energy improvements. Pacific Power may request to inspect your improvements to verify energy savings and quality of installation.
- Step 4: Approved Vendor may deduct the incentive from your invoice, if assigned to them. If not assigned, you will receive your incentive check within 45 days of the complete project submittal.

Step 5: Enjoy energy savings, improved comfort and performance!
